



Concrete Riser and Base Components c/w Rubber Gasket for Joints. Manufactured to CSA Standard.

Notes:

- *Maximum Surface Loading Rate (SLR) into lower chamber through drop pipe is 1135 L/min/m² (27.9 gpm/ft²) for Stormceptor EF10 and 535 l/min/m² (13.1 gpm/ft²) for Stormceptor EFO10 (oil capture configuration).
- 1. Ø3048 mm Manhole manufactured to ASTM C 478 & CSA A257.4 Specifications.
- 2. Stormceptor EF10 to be supplied in components as shown.
- 3. Unit designed to withstand BCL-625 / HS20 live loading.
- 4. Unit supplied with cores for inlet/outlet as shown.
- 5. Unit supplied with lifting inserts as required. Starcon style min. 10T/220mm to be used.
 - Note: Sling angle to the vertical no more than 15°.
- 6. Unit supplied with access opening as required.
- 7. Unit supplied with aluminum ladder rungs as shown. Ladder rungs to be 305mm c/c TYP.
- 8. Minimum concrete strength:
 - Barrel: 30 MPa.
 - Lid & Base: 35 MPa.
- 9. Minimum rebar yield strength: 485 MPa. (Steel Grade: CSA 30.18-400 Weldable)
- 10. Unit supplied with Tylox Super Seal Gasket System for water and soil/silt tight gasket and joint to meet or exceed ASTM C443, ASTM C1619 and CSA A-257.3.
- 11. Minimum WWF yield strength: 400 MPa. (Steel Grade: ASTM A1064)
- 12. Barrels configuration's subject to change based on availability.
